Speaker Biographies



Dr. Kenneth A. Harris is the Executive Director, Office of Specialty Education and the Deputy CEO at the Royal College of Physicians and Surgeons of Canada. Dr. Harris is a Professor Emeritus at the Schulich School of Medicine & Dentistry at the University of Western Ontario (UWO) having spent 25 years in active teaching practice of vascular surgery. He currently holds an appointment in the Department of Surgery at the University of Ottawa and UWO. In his current roles and responsibilities at the Royal College, he oversees educational initiatives in the domain of specialty medicine across the lifelong learning continuum. This includes the setting and evolution of program standards as well as the assessment of specialty candidates. He is the executive sponsor of the Competence by Design project.



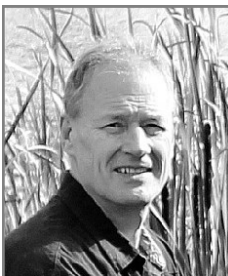
Dr. James Rourke graduated with his MD from University of Western Ontario (UWO) in 1976, where he completed his family medicine training in 1978 and his Masters of Clinical Science (Family Medicine) in 1993. Dr. Rourke was an active rural family physician (including obstetrics and emergency work) in Goderich Ontario for 25 years with his wife and partner Dr. Leslie Rourke. Drs. Leslie and James Rourke are widely recognized as the original co-authors of the Rourke Baby Record — a knowledge translation tool that guides care from birth to five years of age using evidence-based information. Their practice was one of the Rural Family Medicine teaching sites at UWO where he also served as the Assistant Dean of Rural Regional Medicine. Dr. Rourke is an Honorary Research Professor at Memorial University in Newfoundland, and served as Dean of Medicine from 2004 to 2016, and Professor of Family Medicine from April 2004 until retirement April 30, 2019.



Dr. Dave McLinden has enjoyed practicing rural medicine for over 25 years. After graduating from McMaster University in 1991, Dr. McLinden completed his training in rural family medicine in Northern Ontario. He started his family practice in Sioux Lookout and has continued in Huntsville since 2000. He practiced emergency medicine for over 23 years and continues with his obstetrics practice. Dr. McLinden is an associate professor of the Northern Ontario School of Medicine (NOSM), and an assistant clinical professor at McMaster's Department of Family Medicine. In 2018, he was awarded both the NOSM Academic Leader Award and the Physician Clinical Teachers' Association Leadership Award. As the NOSM Site Liaison Clinician for Huntsville, he helps shape medical student curriculum and faculty development on a local level.



Dr. John Rea has been practicing medicine rurally for over 30 years. After graduating with his MD from the University of Ottawa in 1984, he completed a residency in family medicine and emergency medicine at Civic Hospital in Ottawa. After working two summers in the Huntsville emergency department and a year in the emergency department of the Queensway Carleton Hospital in Ottawa, Dr. Rea decided to move to Huntsville and start his family practice. He began teaching with the University of Ottawa's rural medicine program in Sudbury the early 1990's. This program has since evolved into the Northern Ontario School of Medicine (NOSM). As an assistant professor of NOSM, Dr. Rea continues to teach medical learners who visit Huntsville today.



Dr. Rick Senior began his working life as an engineer in the military before returning to school to pursue medicine. He began his medical career as a military MD including stints both as a Flight Surgeon and a Trauma Fellowship at Sunnybrook Hospital. After leaving the military, Dr. Senior worked as a full time emergency department physician and then was an originating member in an eight MD group practice in North Bay, Ontario. His passion is medical education: he has been involved with NOSM since it began and has been the only VAR facilitator in North Bay as well as Site Liaison Clinician and Site Director for many years. He has spoken at a number of conferences both on electronic health records and on medical education.
