**Job Description:**

- Assess community living skills, activities of daily living, functional performance and pre-vocational skills.
- Conduct Occupational Therapy, Attendant Care (Form 1) Assessments, Home Safety Assessments, Activities of Daily Living Assessments, Physical Demands Analysis, Ergonomic Assessments, Seating and Mobility Assessments, Application for Funding.
- Recommend assistive devices, education, and modification to the environment or the manner they engage in an activity, to promote the claimant’s return to their previous level of functioning.
- Administer cognitive testing (MoCA, CASE, CCT, Cognistat)
- Perform Wheelchair/walker assessments, provision of mobility equipment, ADP.
- Assess bed mobility, positioning, and pressure management.
- Assist with discharge planning to ensure home safety.
- Facilitate clients with stroke or traumatic brain injury return to meaningful daily activities through use of upper extremity retraining, activity modification, and appropriate equipment recommendations.
- Provide community-based consultative service to children with global developmental disability.
- Conduct independent living skills assessment of clients to facilitate appropriate supported living arrangements.
- Collaborate with community organizations to provide holistic care to clients.
- Provide education and training about pre-prosthetic preparation to clients with lower and/or upper extremity amputations.
- Collaborate with clients to develop goals and continuously monitor progress towards achieving these goals.
- Maintain clinical notes and progress reports according to COTO standards.
- Experience in the completion of documents required for insurance or medical legal purposes.

- Engage in program development, recruitment and training support staff.
- Provide supervision and direction to multiple Rehabilitation Support Workers within the community, as well as the Occupational Therapy Assistant on staff.
- Develop a strong working relationship with the local vendors.
- Collaborate with medical and rehabilitation team members to effectively manage client care.
- Conduct continuous research in occupational therapy treatment modalities to ensure the highest quality of treatment is being provided to clients.
- Maintain a treatment caseload that includes clients who sustained acquired brain injuries, chronic pain and other various orthopaedic injuries.
- Educate clients and caregivers on energy conservation, compensatory strategies, fall prevention, etc.
- Completion of invoices, OCF-21, and treatment plans, OCF-18, via HCAI.
- Assist clients with leisure goals.
- Equipment needs for clients.
- Housing safety and accessibility.
- Discharge planning.
