KEYNOTE ADDRESS

Traditional wheelchair prescription often overlooks cultural identity, socioeconomic realities, and systemic barriers. How do biases, funding limitations, and policies shape mobility choices? How can clinicians and wheelchair users advocate for inclusive, person-centered solutions?

This keynote will challenge conventional approaches and explore:

- The intersection of IDEA principles (Inclusion, Diversity, Equity, and Accessibility) with rehabilitation technology.
- The impact of restrictive funding policies on mobility outcomes.
- How cultural competence improves device selection, adherence, and satisfaction.
- Strategies to reduce bias in equipment prescription and promote equitable solutions.

A highlight of this session is a panel discussion with members of the Northwestern Ontario Wheelchair Curling Team. These athletes will share their experiences navigating mobility challenges on and off the ice, providing insights into advocacy, resilience, and the need for individualized mobility solutions beyond medical necessity.

With a focus on aligning mobility solutions with client choice, autonomy, and dignity, this session will offer practical tools to move beyond funding constraints and standard checklists. Whether you're a clinician, policy advocate, or wheelchair user, join us to rethink rehabilitation technology, challenge barriers, and drive change in accessible healthcare.

OBJECTIVES:

By the end of this keynote, participants will be able to:

- 1. Identify key systemic barriers (e.g., funding limitations, biases, and policies) that impact wheelchair prescription and mobility choices.
- 2. Explain how IDEA principles (Inclusion, Diversity, Equity, and Accessibility) intersect with rehabilitation technology and mobility solutions.
- 3. Utilize cultural competence strategies to improve client-centered mobility device selection and adherence.
- 4. Examine real-world experiences, including insights from the Northwestern Ontario Wheelchair Curling Team members, to assess how mobility challenges extend beyond medical necessity
- 5. Critique current healthcare structures and policies to determine their impact on client autonomy, dignity, and mobility outcomes.
- 6. Develop advocacy strategies to promote more inclusive, personcentered approaches to wheelchair prescription and assistive technology funding.

WORKSHOP SESSIONS

MAY 9, 2025

SESSION A: THE ASSESSMENT PROCESS FOR WHEELED MOBILITY AND SEATING

Speaker: Jessica Presperin Pedersen

The assessment process is performed with the rider (wheelchair user) and significant others to work with the clinical therapist, supplier, and sometimes the manufacturer to gather medical, physical, functional, and environmental information necessary to determine the parameters for recommending an optimal wheelchair and seating components. The assessment process for individuals requiring a wheelchair or seating incorporates medical history, home environment, transportation, MRADLs, physical & functional abilities, skin integrity, sensation, strength, range of motion, balance, neurological status, sitting posture, transfers, ambulation, wheelchair skills, and measurements. This seminar guides the participant through the process using an evaluation form for documentation, while providing an illustrated overview of the process.

SESSION B: MAT ASSESSMENT

Speaker: Markie Rykman

This training session will review the principles of a thorough MAT assessment from beginner to intermediate in client complexity and equipment considerations. It will include the opportunity to practice the hands-on physical assessment, proper measurement of body segments/joint ranges, translate assessment findings to prescription, and review considerations for equipment configuration to support proper fit and function for each unique client.

SESSION C1: UNLOCK THE SECRETS TO CONFIDENT WHEELCHAIR PRESCRIPTIONS!

SESSION C2: ENHANCING FUNCTION - THE POWER OF POWER ASSIST DEVICES

Speaker: Brenlee Mogul-Rotman

Manual wheelchair propulsion can be inherently difficult, and research shows that the longer a person propels a manual wheelchair for functional mobility the greater incidence of pain and repetitive injury; the resulting pain can limit function, reduce participation, and limit life roles of individuals who use manual wheelchairs for their functional mobility. Power assist devices present the opportunity to reduce pain and improve function of clients who utilize manual wheelchairs for mobility. By understanding the different types of power assist devices available; having the ability to identify the appropriate client; and knowing how to apply power assist devices based on clinical presentation, therapists will be able to improve function, reduce pain, and increase quality of life of the people they serve.

WORKSHOP SESSIONS

SESSION D1: WHEELCHAIR CONFIGURATION

This is a joint session with 4 stations: Center of gravity, seat width, seat to floor height, front end angles.

Speakers: Alli Speight, Brenlee Mogul-Rotman, Tanya Falkenberg

This hands-on workshop will provide an opportunity to explore and discuss key clinical considerations in manual wheelchair configuration. Structured as four rotating stations, attendees will engage in interactive learning focused on center of gravity, front-end angle, seat width, and seat-to-floor height. Each station will be facilitated by clinical representatives from Ki Mobility, Motion Composites, Permobil, and Sunrise Medical. Emphasizing clinical principles rather than product-specific demonstrations, this session will enhance participants' understanding of wheelchair setup and its impact on user function, mobility, and independence.

SESSION D2: CUSTOM SEATING - THEORY, TROUBLESHOOTING AND MANUFACTURER COLLABORATION

Speaker: Jessica Presperin Pedersen

This advanced-level session is designed for clinicians with experience in custom wheelchair seating prescriptions who are seeking to deepen their expertise in complex seating configurations. This course focuses on advanced decision-making theories, troubleshooting common and uncommon challenges and strengthening collaboration with supportive manufacturers. Clinicians will enhance their problem-solving skills, refine their approach to custom seating prescriptions and gain insights into optimizing comfort, function, and mobility for individuals with complex needs
