Senate Business – Committee Highlight

Admissions Committee – by Dr. Paul Miron, Assistant Dean - Admissions & Enrolment and Senator

The Admissions Committee presentation provided an overview of how NOSM University's admissions governance and operational structures work together to support the MD admissions cycle. At the top is the main Admissions Committee, which sets standards and provides oversight. Much of the ongoing work happens through several specialized subcommittees aligned with key pathways—Black, Indigenous, and Francophone admissions—as well as additional committees convened as needed for disability or exceptional-circumstance considerations and for final applicant selection.

The presentation also highlighted the role of the Admissions Office, a small but highly collaborative team that manages the data, processing, and coordination throughout the year, working closely with units such as UME, Indigenous Affairs, and Francophone Affairs. Finally, the committee reviewed high-level trends in admissions data from the past five years and discussed external pressures and continuous quality improvement efforts that shape the admissions process.
